## **Bioethics and Bio-politics**

27 – 30 August, 2014 Debrecen, Hungary

This conference will be organised by the European Society for Philosophy of Medicine and Healthcare (ESPMH) and the Department of Behavioural Sciences, University of Debrecen, Hungary.

#### **Focus**

The term "bio-politics" is either used as a philosophical or sociological term referring to the works of Negri, Agamben, Rose, or Foucault, who focused on the contemporary style of governing populations through bio-power, or as an umbrella concept referring to public policies regarding applications of biotechnology and the life sciences. Both usages suggest, that bio-politics is a central concept for modern societies. At the same time bioethics has become increasingly interdisciplinary and ever more politicized. Bioethical issues figure in presidential campaigns and parliamentary elections. Bioethicists are advisors for governments and frame recommendations for public policies. Bioethics and bio-politics have become deeply interwoven activities.

If bioethics and bio-politics are highly interwoven, then how should we understand their relationship? Does politics corrupt bioethics? How does bioethics affect policy-making? How has bioethics been affected by its role in policy-making?

Abstracts addressing these issues in the following topics will be favoured, although work on other topics can also be submitted:

## **Getting to Debrecen**

## By train

Debrecen lies on the No. 100 line of Budapest-Szolnok-Debrecen-Nyíregyháza-Záhony direction, not incidental therefore that this is one of the most developed railway junctions of the country. At the same time, Debrecen also enables international transportation by train to Romania, Ukraine and Slovakia as well. The MÁV (Magyar Államvasutak, Hungarian State Railway Company) supports the major lines with InterCity (IC) trains.

## By air

Directly to Debrecen Airport: Wizzair currently operates international flights from London Luton (4 days/week), and also from Eindhoven (2 days/week). Germania operates occasionaly flights from Berlin. More flights are announced from March 2014 (http://www.debrecenairport.com/?lang=en).

Indirectly: via Budapest- Liszt Ferenc (BUD) International Airport <a href="http://www.bud.hu/english">http://www.bud.hu/english</a>. The old name of the airport is Ferihegy. It serves a great number of international airlines. From Budapest Airport take bus number 200E to Ferihegy train station (20 min.) where you can take an intercity train to Debrecen.

#### By car

From Budapest, the M3 continues as the M35 highway directly leading to Debrecen. The journey from the capital takes approximately 2-2,5 hours. Other regional centres can easily be reached from Debrecen: you can reach Miskolc and Nyíregyháza – and through these Slovakia and the Ukraine – on highways M35 and M3, or M30. Debrecen is also a gate to Romania, which can reached directly on road No. 47 via the border town of Ártánd.

## **Currency**

The currency in Debrecen is the Hungarian Forint (HUF). Foreign currency can be easily exchanged at banks or exchange offices. Visa and Master cards are widely accepted. ATMs can be found at several places both in the city centre and in the campus area. S shops accept Euro banknotes as well.
